# THE ORIGIN AND HISTORY OF THE NAME "PARRISH" AND COAT OF ARMS

### PARRISH—England:

In the history of surnames we find the two names given "Paris, (Parris)" as a Norman French name, and "Parish, (Parrish)" as a name taken from locality, with the remark that these two names have become confused.

This seems to be borne out in the records about the time of the migration to the American Colonies, so far as the spelling of the name in England is concerned.

The family appears earliest under the spelling of "Paris" in Lincolnshire and later in Hertfordshire and, considerably later, the name appears in Middlesex. It is from this latter place that the New England family traces their descent. It has been inferred that the name was originally "de Paris" and that "Parrish" is a corruption of "Paris." The name in England usually is spelled with one "r" for both forms. In America, in Maryland it was "Parish" and "Parrish" and now is "Parrish."

The name is not common in England. The following abstracts show the general trend of the early family name in England:

Knights of King Edward I:

Sir William de Paris, Knt., "de Sable CuSSile argent e an chevron d'argent. Lincolnshire... sealed as lord of Morton by Horncastle, Lincolnshire, early 14th century. A chevron between 10 crosslets (Birch)."

He was summoned to serve against the Scots, June 30, 1314.

He was summoned as a Knight of Hertfordshire, to serve in person June 20, 1322, against the Scots.

He was summoned to the Great Council at Westminster, May 9, 1324, but was so ill, his life was despaired of.

He was summoned on Jan. 26, 1326.

An earlier William de Paris, Knt., held land in Bucks, Dec. 16, 1246, and was dead Dec. 28, 1255, leaving co-heirs.

Early Chancery Records, 1385-1467, page 39, give the following variations on this name in Suits:—Paryce, Parys, Paryse, Parysh, with the given names as John and William predominating and the following names only one time: Alice, Beatrice, Henry, Robert, Thomas, Richard, Joan.

Robert Parris of Hitchen, Hertfordshire, son of Thomas Parris, gent., was granted use of Arms, June 15, 1573.

Genealogical Gleanings in England (Waters) Vol. I, page 143:

John Parris, Island of Barbadoes, Esq., left a will dated May 15, 1660, probated Oct. 3, 1661, naming wife Susanna. He had no children so entailed his estate to his brother Thomas Parris' three sons, Thomas, Samuel and Martin. It was these young men who came to New England. This will names a brother Richard Parris, deceased, and his daughter, Sarah; sisters, Margaret Bulby and Rebecca Parris and cousin Thomas Martaine's son, Thomas, and sister-in-law Susanna Parris. She was the wife of Thomas Parris who died in the Barbadoes while there on business. His estate was in the County of Middlesex, June 9-10, 1665.

In a study of the coats of arms used by men named "Paris" and "Parish" from the very earliest one down, there is a striking similarity in design though no one line seemed to carry the use of arms on continuously. Even in the design of their coats of arms the two names seem confounded.

For Parish: gules 3 unicorn's heads couped argent; crest a unicorn head erased

argent.

This in variation is used for Paris, of Lincolnshire, and, in 1573, for Paris of

Hitchen, Hertfordshire. (See Burkes General Armory.)

The 10 crosslets and chevron is used by the Paris of Lincolnshire as the oldest form.

Edward Parrish died 1783 ac 73; d.s.p. (died without issue).

# DRUID HILL PARK, BALTIMORE, MD.

ANCIENT SITE—1709 TO NICHOLAS ROGERS

(Originally "Parrishes Range." Surveyed for Edward Parrish, 1678.)

Thomas Darling patented 350 acres, 1688, out of a tract of 2000 acres to Thomas Richardson. Said Thomas Richardson set out this 350 acres to Thomas Darling (Durbin) under the name of "Hob Nob at a Venture," and the patent of 350 acres in 1689 to Thomas Darling has the same metes and bounds.

Solomon Jones patented, 1688, 150 acres of "Jones Level" (part of Druid Hill

Park)

John<sup>2</sup> Cole patented, 1704, 126 acres of "Happy be Lucky."

John<sup>2</sup> Cole patented, 1714, 300 acres of "Hap Hazzard."

East of "Happy be Lucky" and bordering on "Hob Nob at a Venture" was the 282-acre tract put to Daniel Richardson, Nov. 24, 1694, as "Come by Chance."

North of "Hob Nob at a Venture" and "The Level" lay "Parrishes Range" and "Parrishes Fear." The former patented for 2000 acres to Edward Parrish of Anne Arundel County, Oct. 5, 1678, and "Parrishes Fear" for 330 acres to Edward Parrish, Mar. 25, 1714. Out of the whole of "Hob Nob." "The Level," and some parts of "Happy be Lucky," "Hap Hazzard," "Come by Chance," and "Parrishes Range" and "Parrishes Fear" came the whole area now municipally owned and known as Druid Hill Park, Baltimore, Md.

Thomas Darling's son Christopher, was a carpenter. John Gardner, carpenter, 150 acre farm of "Hob Nob."

John Gardner, 200 acres of "Jones Level" for Solomon Jones.

John Gardner, 126 acres of "Happy be Lucky" for John<sup>2</sup> Cole.

John Gardner, 300 acres of "Hap Hazzard" (1726).

(He died in 1740 and lands were sold to Dr. George Buchanan.)

NOTE: Of the owners, we have the following information: Dr. George Buchanan died in 1750. He had married Elenor's Rogers (Nicholas', Nicholas'), and through her inherited 200 acres of "Hob Nob at a Venture." William Rogers, her brother, died 1761. John's Cole had married, before 1691, Johanna's Garrett, daughter of Dennis's Garrett and Barbara his wife.

# EARLY PARRISH HISTORY IN AMERICA

Previous family histories state that Edward Parrish of Anne Arundel County, Md., was born about 1600 in Yorkshire, England; that he came to Maryland about 1635, as Surveyor General of that Province; that he nad been in the English Navy and had made several voyages to America for Lord Baltimore before deciding to settle in Maryland; that about the year of 1634 large grants had been given to him for transporting many of the early settlers; that about 1652 he and his brother, Robert Parrish, organized troops against the Nanticoke Indians for which they had received payment in tobacco; that in February or in April of the year of 1679-80 he was drowned when his ship capsized in Maryland waters, leaving a wife, Clara, and six children to survive him; that Clara had refused administration of his estate whereupon Colonel Thomas Taylor assumed that responsibility.

NOTE: Robert Parrish of the Eastern Shore, who married Cicely Jadwin, was supposed to have been Edward's brother; a third brother was stated to have come into the colony with them.

These historians go on to state that this Colonel Thomas Taylor absconded with all of the personal property and returned to England, adding that the widow, Clara, may have married him and acompanied him to England, as so little is found about her after 1680.

This Colonel Thomas Taylor of Anne Arundel County, Md., was Burgess in 1669; Speaker of the Lower House of the Assembly in 1670; and he made a trip to England in 1671, returning before 1678. (Ref. Md. Arch Vol. 2, pp. 157, 312, 340, etc.

Careful research among the early court records of the colony of Maryland has disclosed no proof for the foregoing account of Edward<sup>1</sup> Parrish. Exhaustive research and close analysis of the items found give a less fanciful but clearer picture of Edward<sup>1</sup> Parrish and his activities, which disproves some of the claims made about him.

Virginia records show that an Edward Parrish entered Virginia in the year 1635, the year in which tradition has stated that the immigrant ancestor of the Parrish Family came to the New World. (Ref. Greer's Early Virginia Emigrants: "Edward Parrish, imported by Adam Thoroughgood.")

This points to the possibility that Edward Parrish. of Anne Arundel County, Md., was a son of this Edward Parrish of Virginia, and went to Maryland with, or to, his childless kinsfolk. James and Susannah (Ewens) Billingsley, of Calvert County, Md., to serve an apprenticeship of seven years and to establish himself. Tradition often confuses the actions of two men of the same name in this manner.

This earlier Edward Parrish settled in Elizabeth City County, Va., and may even have fought the Nanticoke Indians, who were troublesome on the Eastern Shore of Virginia as well as to the Marylanders.

The early records of Elizabeth City County have been almost entirely destroyed, and though Parrishes appear there in the next generation. no proof for connections is obtainable and no Edward Parrish shows up in Virginia in the next generation.

Other facts bearing out the above supposition are in existence as follows: James Billingsley had a brother, Thomas, and three cousins in Virginia. Susannah, wife of James, left a bequest to Edward¹ Parrish. Captain William Burgess signed a bond for Edward¹ Parrish. The families of Captain William Burgess, George Puddington. Richard Wells. Captain Edward Robins. Obedience Robins, Richard Beard, John Waters, and Richard Ewens, were all in Virginia before becoming neighbors of Edward¹ Parrish in Anne Arundel County. Md.

These were all prominent families, closely related through intermarriages and they were friends of, and intimate with, Edward<sup>1</sup> Parrish and his sons. There is no proof in the records I have examined, that Edward<sup>1</sup> Parrish was any kin to other persons by that name who were contemporary with him in Maryland (except his children).

### THE PARRISH LINEAGE OF MERCELIA LOUISE BOYD

#### FIRST GENERATION

1. EDWARD PARRISH, The Immigrant to Maryland.

Born about 1640, probably in England (or Virginia).

Died 1680, intestate, in the early spring of the year, at his home place in West River Hundred, on Herring Creek, about seven miles below Annapolis, Anne Arundel County, Md. Buried there, with wife, Clara.

NOTE: His son, Edward, in his will, dated 1722-23, directed that the graves of his father and mother be repaired and cared for. Thus if Edward Parrish did die by drowning in the Chesapeake Bay, his body was recovered and brought home for burial.

He left wife, Clara, and at least five children under age. This is proved by the fact that they were not required to administer or renounce administration of the estate, as did their mother.

MARRIED about 1664 to Clara, in Maryland. Her maiden name is unknown.

His occupation: Planter.

She was born about 1640-42.

She died before 1720 at her home place. Buried there.

Clara Parrish signs her renunciation as administratrix of the estate of Edward' Parrish on Apr. 17, 1680, and at her request Colonel Thomas Taylor was appointed administrator, with Richard Gassoway, as security. (Ref. Testamentary Proceedings, Book 12, page 35, State Land Office, Annapolis, Md. Provincial Court of Maryland, Book 2, page 329, Mar. 3, 1679, Annapolis, Md. Inventory of Accounts, 1680-1682, Vol. 7A, page 66.)

Edward Parrish was imported into the Colony of Maryland in 1655 by William Piper, of the Isle of Kent. (Ref. Land Office, Annapolis, Md., Vol. 5, page

489.

Edward' Parrish demanded land for performing his time of service in this Province, 50 acres, Nov. 26, 1662. (Ref. Book 5, page 486, Land Office, Annapolis, Md.) On the same date George Pascall demanded 50 acres in the name of his wife, Mandeley, for performing her time of service. This 50 acres was assigned to Edward' Parrish. (Same reference, page and date.)

NOTE: Every man was allowed 50 acres of land for himself or for anyone whom he transported into the Colony, unless he were under age. These were called "headrights," and they were granted to all free men, upon application.

NOTE: Old Style calendar carries 1662 over into the first three months of what we would call 1663 today. Thus, January, February and March are written 1662/3.

This is the earliest record of Edward<sup>1</sup> Parrish found in Maryland, and this 100 acres, plus the additions to it, were called "Parrishes Park."

The next actual record of this Edward Parrish of Anne Arundel County, Md., is found published in the archives of Maryland, Vol. 2, page 228, dated April-May, 1669, showing that 8000 pounds of tobacco were ordered paid to Edward Parrish, John Thurston, Mathew Axton and Abram Duttenat.

He acquired additional land rapidly, made a practice of leasing it instead of working it himself, and sold only one piece. Therefore, there was little chance

for his wife to appear on the records.

His first survey was made in the year 1662-63, and his eldest son, Edward<sup>2</sup> Parrish, is mentioned as having possession of this first piece of land. The following is from the Rent Rolls of Anne Arundel County, Md. Lands all located in that county:

"Parrishes Park" 1662, 100 acres.

Certificate, Book 7, page 193. Patent, Book 7, page 194.

Surveyed Mar. 22, 1662-63 for Edward Parrish. It was located on south

side of West River at the head of Cuttle Creek. (Calvert Papers, page 19.) "Clary's Hope" 1663.

Surveyed July 10, 1663, for Edward Parrish. (Calvert Papers, page 19.)

"Clary's Hope" 1664, 150 acres.

Certificate and Patent, Book 7, page 192.

"Parrishes Delay" 1670, 100 acres.

Certificate, Book 16, page 156. Patent, Book 14, page 297.

Surveyed Dec. 16, 1670, for Edward Parrish, and located in Herring Creek Swamp. This was sold to John Beak.

"Parrishes Choice" 1670, 150 acres.

Certificate, Book 1, page 27.

Surveyed Mar. 18, 1670, for Edward Parrish and son.

"Parrishes Chance" 1670, 150 acres.

Certificate, Book 12, page 633.

"Locust Neck" 1671, 50 acres.

Certificate, Book 16, page 161. Patent, Book 16, page 200.

Surveyed May 18, 1670. (Calvert Papers, page 13.)

"Papa's Ridge" 1673.

Surveyed July 13, 1673, for Edward Parrish. (Calvert Papers, page 10.) Located on the south side of West River.

"Papa's Ridge" 1674, 155 acres.

Certificate, Book 17, page 20. Patent, Book 18, page 212.

"Parrishes Range" 1678, in Baltimore County, Md.

This land was again patented in 1696, by Edward<sup>2</sup> Parrish, the son. Book C #3, page 417.

This was the largest tract of land owned by Edward<sup>1</sup> Parrish. It was surveyed for him Oct. 5, 1678, (Calvert Papers, page 184) and remained in the family for many generations. It consisted of about 2000 acres.

"Parrishes Fear" was patented by Edward<sup>2</sup> Parrish, son of Edward<sup>1</sup> Parrish, in 1714.

Surveyed Mar. 25, 1714, for Edward Parrish (Calvert Papers, page 286.) Located between Gwins Falls and Jones Falls. Now Gwinn's Falls Park.

A part of "Parrishes Range," with a part of "Parrishes Fear," is now included in the Druid Hill Park, owned by the City of Baltimore, Md.

## 2. WILLIAM<sup>2</sup> PARRISH (Edward<sup>1</sup>)

Born about 1678 in Anne Arundel County, Md. Died about 1771-72 in Baltimore County, Md.

Buried in Gunpowder Burial Ground, Baltimore County, Md.

He was the youngest child and was about two years old when his father died.

He was living in 1769-70, and transferred land in 1769.

MARRIED before 1718 to Susannah (Her maiden name is unknown).

Resided where the City of Baltimore, Md., now stands, on part of "Parrishes Range," left him by his father, near Gwins Falls and Garrison Road. He was a neighbor of his brother, John<sup>2</sup> Parrish, and Peter Bond, Jr., a Quaker.

She was born about 1678-80.

She died after 1756.

She was living in 1737, and we have no records of her after 1748.

His occupation: Planter, and possibly professional man, which would be indicated by the fact that he was appointed by John Earp of Stafford County, Va., and Joseph Earp of Anne Arundel County, Md., as their lawful attorney.

He was co-executor of his friend, Peter Bond, Jr., and also the guardian of his orphan children.

He made a deposition in 1732 stating that he was about fifty-four years old. Also another deposition made prior to Mar., 1744-45, stating he was about sixty years old.

He sold 70 acres of "Parrishes Range" lying next to "Newtown" to John Stewart.

NOTE: Reference for petition and depositions recorded in Provincial Court. Published also in the Maryland Historical Society Magazine.

That William<sup>2</sup> Parrish was the son of Edward<sup>1</sup> Parrish and Clara, his wife, is established through the following records:

The administration papers of the estate of John<sup>2</sup> Parrish in 1727 show that one of the administrators was William<sup>2</sup>, the brother of the deceased John<sup>2</sup> Parrish. (Ref. Adm. Acct. Book 3, page 70, Maryland Land Office, Amapolis, Md.) The marriage record of this John<sup>2</sup> Parrish states that John<sup>2</sup> is the son of Edward<sup>1</sup> and Clara Parrish.

The will of Edward<sup>2</sup> Parrish, 1722-1723, devises to "my cousin Edward<sup>3</sup> Parrish, son of William<sup>2</sup> Parrish; to my cousin Edward<sup>3</sup> Parrish, son of John<sup>2</sup> Parrish;" cousin being the common term for nephew at that time. These two legacies were bequeathed to two nephews named Edward<sup>3</sup> Parrish. (Ref. Book 18, page 153, Maryland State Land Office, Annapolis. Abstract published in Baldwin's Abstracts of Maryland Wills, Vol. P.)

A quitclaim deed made by Edward<sup>3</sup> Parrish and Rachel (Harwood), his wife, to his uncle, William<sup>2</sup> Parrish. Edward<sup>2</sup> Parrish was heir-at-law of his father, Edward<sup>2</sup> Parrish, and held title to any un-deeded or unbequeathed lands of his father. Edward<sup>2</sup> Parrish had laid off 80 acres of the lower end of "Parrishes Range," in Baltimore County, for his brother, William<sup>2</sup> Parrish, at some earlier date, but had never made a deed of conveyance to the said William. This was done after the death of Edward<sup>2</sup> Parrish, which was in 1722-23. (Ref. I.S. No. 1, page 86, 1727.) This release was signed by Edward<sup>3</sup> Parrish to William<sup>2</sup> Parrish under date of 30 Nov., 1727. On the back of deed-agreement was signed the name of Rachel Parrish, wife of Edward<sup>3</sup> Parrish.

Shortly after the title to the 80 acres of "Parrishes Range" was secured by William<sup>2</sup> Parrish he made several deeds to parts of it. He retained a small piece of this land until Oct. 11, 1769, when he transferred to Leonard Helm, a house carpenter, of Baltimore County, Md., all the remaining part of the 80 acres of "Parrishes Range" which had not already been conveyed by William to Leonard

Helm, his friend and kinsman. In these deeds, up until 1756, his wife Susannah signs with him. After that date no wife joins him in the deeds. It is quite probable that she died about that time.

The Quaker records of Anne Arundel County, Clifts Monthly Meeting, 3 da. 11 mo. 1700-01, show that William<sup>2</sup> Parrish attended the marriage of his brother, John<sup>2</sup> Parrish, and signed as one of the many witnesses.

The Quaker records of Baltimore County, Gunpowder Monthly Meeting, contain the following items on the membership and behavior of William<sup>2</sup> Parrish:

William<sup>2</sup> Parrish, Sr., witness in 1742 to the marriage of his son, William<sup>3</sup> Parrish, with Keturah (Merryman) Price. Also his wife, Susannah, was present at the time and signed. (Ref. page 6, Misc. Min. Book.)

William<sup>2</sup> Parrish, Sr., in membership with his wife, Susannah, page 42 (1748). William<sup>2</sup> Parrish, Sr., witness in 1745 at the marriage of his daughter, Su-

sannah to Aquilla Carr. (Ref. Shelf #123A, page 10.)

William<sup>2</sup> Parrish, Sr., was requested to write a letter acknowledging his misconduct in insisting upon deciding a difference with a friend before a justice. (Ref. Misc. Minute Book, Friends of Baltimore County, 1739-79. Page 97, 27 da. 7 mo., 1758. Also Shelf \$123A\$, page 97.)

He was an Elder in the Quaker Meeting in 1757 and he resigned as an Elder in Gunpowder Meeting, 28 da. 2 mo., 1770, probably on account of old age.

(Ref. Book A, page 228, 22 da. 10 mg., 1766.)

Both William<sup>2</sup> and Susannah brought an injunction suit, Dec. 4, 1744, against John and Lydia Metcalf. (Ref. I.R. page 454, Anne Arundel County, Md.)

The following are the only transactions found in the Baltimore Court House for William<sup>2</sup> Parrish: (Ref. Baltimore Court House, I.S. No. 1, page 301.)
William<sup>2</sup> Parrish transfers to Stephen Gill part of "Parrishes Range," 75 acres, on north side of Patapsco River, 30 Mar., 1729. This deed was recorded 2 May, 1729.

Jan. 2, 1718, "Talbots Plains," 150 acres, John Talbot to William<sup>2</sup> Parrish.

Mar. 26, 1729, "Gills Fancy," Stephen Gill to William<sup>2</sup> Parrish.

Mar. 28, 1829, "Talbots Plains," Mary Talbot to William<sup>2</sup> Parrish. (Ref. I.S. No. L, page 39.) Jan. 1, 1730, this same tract transferred by William<sup>2</sup> and his wife, Susannah, to George Walker.

Transfer of land made by William<sup>2</sup> Parrish, Sr., 1756-57, no wife mentioned.

MARRIED 30 da. 1 mo., 1744, to Mary' Price in Baltimore County, Md. (Ref. Minutes of Gunpowder Monthly Meeting, Book "A", page 8, 1739-1768, 36 Witnesses.)

She was born 20 da. 1 mo., 1726, in Baltimore County, Md.

She died 21 da. 8 mo., 1793, in Baltimore, Md.

His will is dated Aug. 27, 1826, probated Nov. 26, 1826, in Cadiz Court House, Harrison County, O. (Will Book A. page 178. Adm. Docket "A," page 133.) Bequests: To wife, Rachel, My mansion house and homestead plantation.

To daughter, Edith Blake, Lot \$168 in Nathan Adams Addition to the Town of Cadiz, with house and smith shop. At her death these are to return to my granddaughters, Anne and Eliza Swan.

To daughter, Urith Stubbins.

To sons, Leonard, Jarret, Benjamin, Peter and Mordecai.

"Women Friends produces an Essay of a Certificate for Rachel Parrish, to Plymouth Monthly Meeting in the State of Ohio, which was read, approved and signed and directed to be transcribed and forwarded."

Old record of the Plymouth Monthly Meeting held 19 da. 2 mo., 1816, reads as follows:

"A certificate for Rachel Parrish, from Gunpowder Monthly Meeting in Maryland, dated 22 da. 11 mo. 1815, was read and directed to be endorsed to Short Creek Monthly Meeting."

The following is quoted from Mrs. Elza R. Hall, R.F.D., Aldena, Ohio, who is the custodian of these old records at this time (1935):

"The records state that Plymouth Monthly Meeting was first opened 19 da. 3 mo. 1808. It was composed of Cross Creek and Plymouth preparative meetings and designated 'Plymouth Monthly Meeting.' In 1817 the name was changed to Smithfield, at which place it was held from the beginning, as I understand it.

"After the Guernsey Separation in 1854, those who clung to the original Orthodox Friends were so few, that in 1855 they asked to be joined to the Short Creek Monthly Meeting, from which they were originally set off, and Smithfield Conservative Monthly Meeting was laid down, the books and records to be the property of Short Creek Meeting, of which I am a member, hence my care to these records. Smithfield is a small village in Jefferson County, within ten or twelve miles of Steubenville, Ohio."

"Price's Hunting Ground," 45 acres, in Baltimore County, Md., was deeded to Mordecai<sup>4</sup>, May 27, 1793, by John Price, John Parrish and Mary, his wife. (Ref. Book W.G. No. L.L., page 297.) This tract was originally surveyed for John<sup>3</sup> Price, who deeded it to Mary<sup>4</sup> Parrish.

Mordecai and wife, Rachel, deeded to Hickman Johnson a part of "Price's Hunting Ground," and an addition to same of 60½ acres. Also a tract of 65334 acres called "Hardin's Neglect." (Ref. Book W.G. 133, page 155, Oct. 2, 1815, Baltimore County. Md.)

Other letters dated at Moorfield, Harrison County, O., Apr. 9, 1852, Feb. 5, 1853, Apr. 1853, contain nothing of importance except the continual reference to the hard struggle the families are having in getting along, and the various townspeople returning from California, some with gold and some "strapped." June 5, 1853, from Moorfield, O., quoted: "The Craigs and Gilmores are herding large flocks of sheep in Illinois and have made fortunes in three or four years. Large emigration this Spring to the Wilderness, not less than fifty thousand wagons, and more going."

"Charles and his wife are living at home with father."

Mar. 26, 1854, from Moorfield, O., mentions that he (John) is selling out and again starting for Mendota, Illinois, and is undecided about going by land or water.

John<sup>6</sup> Parrish made his home with Mary Jane<sup>3</sup> (Clokey) Parrish, wife of Charles Albert<sup>6</sup> Parrish, his brother, after his return from the Civil War.
